

A real estate investment group focused on reclaiming, redeveloping and rebuilding Black communities across America.











What We Do

02. Acquire Real Estate






The OASIS Model



RECLAIM


We identify and acquire properties in predominantly Black communities.



We invest in the full renovation and redevelopment of acquired properties.




REDEVELOP

We build a real estate portfolio that collectively raises the value of our communities, improves the quality of life in our communities, and gives us the power to design the future of our communities.





Who Can Invest

We allow anyone to invest in our fund, be awarded a percentage of equity in the fund's portfolio, and subsequently secure a potential return on their investment.

As an SEC Certified Regulation A+ Tier II fund, we are the only active Black-owned real estate investment group that can accept funding from unaccredited investors.

What's an Unaccredited **Investor?**

An unaccredited investor is an investor that does not meet the minimum net worth or financial criteria required to receive certification as an accredited investor from the Security and Exchange Commission (SEC).

Ownership allows us to improve and advance Black communities socially, politically and economically.








OASIS is Vertically Integrated

Since Co-Founding OASIS Faheem has served as the companies CIO leading all new real estate acquisitions, capital investment and management.







The Communities We Target
